Minute of the Meeting of Kelso Community Council held on Tuesday 14 May 2024 at 7:00 in Kelso Town Hall

<u>Welcome</u>

The Provost welcomed everyone to the meeting.

He introduced Norman Burr and Lesley Muter, both of whom wished to address the Community Council regarding ASSET (Association of South Scotland Entertainment Tent). Lesley advised the meeting that ASSET had been formed in July 2023, when a marquee had been gifted by Yetholm Community Council. The aim was to help the local community to run events by offering the use of the marquee at a fee of £250 per event, which includes erection and dismantling). Norman handed round photographs and said the marquee was 10 x 20 metres. ASSET simply wanted to break even – they were not wishing to profit from the hire.

The Provost thanked Norman and Lesley for coming along to the meeting.

Police Matters

The April MMWR had been circulated. There was no Police Scotland representative in attendance.

SBC Councillor T Weatherston advised the meeting that he had raised several issues with the Police.

The Provost told members that a lady who had been receiving abuse from a group of teenagers reported the matter to Police Scotland. The School Liaison Officer detected the culprit(s) and they had subsequently been charged with verbal abuse. He stressed that this was a good example of reporting incidents such as this to Police Scotland.

Visit Kelso

The Provost advised members that Adrian Clarkson, of Visit Kelso, was unable to attend the meeting due to ill-health. He had, however, emailed a report and the Provost read this out as follows:

"The hanging basket uptake for the coming year has been very good with 85 baskets being prepared (will be put up 6th June).

Membership invoices have been sent out and it is hoped that renewals will be strong. Work is always on-going to attract new members.

The current social media and Instagram contractors are resigning at the end of May and work is in progress to replace them.

Work is on-going to review the Visit Kelso website to make it more user-friendly and easier to locate pages."

Declarations of Interest

There were no Declarations of Interest.

Minute of the meeting held on Tuesday 12 March 2024

The Minute of meeting of Tuesday 9 April 2024 had been circulated and was approved. The Minute was proposed by Councillor James Boulton and seconded by Councillor Peter Cooper.

Matters arising from the Minute

There were no matters arising from the Minute.

Questions From The Public

There were no questions from the public.

Kelso in Bloom

The Provost advised that the next litter-pick was taking place on Thursday 23 May 2024 at 6pm. The planting at Bridgend Park was almost complete. An application had been submitted to this year's Greener Gateway Competition, organised by SBC and a grant of £500 had been awarded from Charity Begins At Home.

Community-Led Planning

The Provost advised the meeting that Beth Landon was giving a talk on Tuesday 28 May 2024 at 7pm in the Town Hall on Community-Led Planning. This had been advertised in Kelso Life and on social media. It was hoped that as many community groups as possible would attend and become involved.

Scottish Borders Community Council Network

The Provost requested the SBC Councillors to enquire whether the SBCCN is still active and what is the state of their finances? SBC Councillors Weatherston and Robson agreed to this course of action.

It was noted that Councillor McGrath, who is the SBCCN representative, had tendered his apologies and was not at the meeting and therefore unable to answer any questions the Community Council had.

An email had subsequently been received from Scottish Borders Council advising that a Working Group would be drawn up from existing Community Councils to carry out a review of non-financial groups, including the SBCCN. The Provost, together with Councillor J McCombie, would be the representatives from Kelso Community Council on the Working Group.

Provost Report

- Members were advised that 2 Polish flags had recently been flown from Kelso Town Hall. The Provost and his wife Lorna, were invited every year to the Polish Embassy in Edinburgh to an Ambassador's Dinner this year, the dinner was being held on 14 May 2024 and the Provost had given his tickets to Mr and Mrs Harry Tomczek (It was noted that American flags had been displayed to commemorate American Independence Day last year).
- The Provost said he was still very keen to have a digital display in the Town Hall window. He said that a 47" TV screen and a basic computer would cost approximately £500 and he felt this would be an excellent way to display tourist information. Councillor S Redgrave requested that the Provost get the exact figures and ask the Community Council for approval at a future meeting. It was noted that this funding would come from the surplus of the 2023 Walking Festival.

Secretary's Report

Events/Correspondence

Correspondence, consultations, planning, traffic regulations etc. had been circulated and a summary was attached to the Minute.

An email from Scottish Borders Council had been received inviting applications for the annual Community Paths Maintenance Grant. It was noted that the grant amount had been increased to £600 for 2024-25 and the deadline for submission is **13 December 2024.** Members were advised that it was usually the Heritage Society who received this grant but if there were any other groups who would benefit from a share of the total, please let the Community Council know.

The annual Charity Begins At Home Awards ceremony was taking place on Sunday 2 June 2024 at 2.30 in the Cross Keys Hotel, Kelso. Councillor Paul Roberts kindly offered to attend and accept the cheque on behalf of Kelso Community Council.

Consultations

Members were advised that there was 1 ongoing consultation and that was the Decriminalisation of Parking in the Borders. There was a link on the SBC website for comments and he urged members to give their views.

There had been a consultation by Boundaries Scotland on revised constituency boundaries for the Scottish Parliament. It was noted that this had been received by Councillor Redgrave on 13 May 2024 and the closing date for submissions was 15 May 2024. SBC T Weatherston said this was probably because there were no proposed changes for the Scottish Borders Council area but the Secretary was asked to write to Boundaries Scotland to complain about the short notice and request that this did not happen in the future.

Scottish Borders Council Report

a) Town Hall Flags

The Provost commented on the poor repair of the existing flags on the Town Hall and said it was a very poor reflection of the town. SBC T Weatherston said he had no idea who was responsible for the maintenance of the Town Hall but he would email SBC Property again and ask that the flags be replaced as soon as possible.

The Provost advised that there were 2 flagpoles outside the Tait Hall and would it be possible to obtain flags for these for the summer?

b) <u>Town Twinning</u>

SBC Councillor E Robson raised the subject of Town Twinning, saying that Kelso used to be twinned with Orchies in France and should the Community Council be looking to revive this Group? The Provost said that the Twinning with Orchies had been wound up and any funds left had been donated to Charity Begins At Home. He himself had been involved with a school visit to Orchies and he felt that the Group had been wound up due to the expense. Councillor Robson asked if a post could be put on the Community Council Facebook Page to ask if there was any interest in starting it up again.

c) Vandalism to Lifebuoys

SBC Councillor E Robson said he was sorry to have to relay to the meeting that there had been some vandalism to the lifebuoys at The Cobby – he was not sure at

this time how much it would cost to repair/replace them but he knew there was a small amount of money left in the Water Safety Fund which could perhaps be used.

The Provost advised that there had been a dead sheep lying in The Cobby for some time, this was being arranged to be removed.

d) CamperVan Overnight Parking

The Provost advised that it would be really good to get somewhere for campervans to park overnight in Kelso. It was noted that there were no signs at Mayfield saying they couldn't park overnight. SBC Councillor T Weatherston said it had been noted that there was definitely a requirement for overnight parking for the campervans.

e) <u>CCTV</u>

The Provost asked SBC Councillor E Robson if he would check whether the CCTV camera at the public toilets was working.

f) Maxmill Park

SBC Councillor E Robson advised members that they would be delighted to know that Scottish Borders Council had approved the demolition and sale of the site at Maxmill Park. The process was now underway.

There were no new Licensing applications for consideration at this time.

The premises are set within the conservation area and the setting of such should be protected from retrospective alteration that is not in keeping with the surrounding premises.

Quote section 6.3 on the Supplementary Planning Guidance on Shop Fronts and Shop Signs, "the use of brash colours will rarely be successful".
