The Provost welcomed everyone to the meeting and wished those present a Happy New Year. He expressed best wishes to Councillor Colin McGrath who is recovering well and is now in Kelso Hospital. Colin would welcome visitors.

Police Matters

The December MMWR had been circulated. There were no comments made on the contents of the report.

Visit Kelso

Visit Kelso sent their report as follows:

Feedback from the Christmas Market, held on 14/15 December 2024 showed that it had been a great success. All 30 stalls had received excellent comments. The entertainment and activities held in The Square had also been well-attended and enjoyed by the public.

The Kelso Agricultural Society held a "Christmas Tractor Run" which had received an outstanding number of entries. The proceeds from this event had been donated to Charity Begins At Home.

There had also been a "Christmas Cracker Trail" which was a new event this year. It was primarily for children and involved finding the shops which had placed a Christmas Cracker amongst their window display. There was a small reward for everyone at the conclusion of the "Trail".

There had been excellent comments received from both the public and visitors on this year's Christmas Lights display. The Provost thanked the Kelso Christmas Lights Committee for all their hard work in putting on such a wonderful show for the town.

Minutes of the meeting held on Tuesday 10 December 2024

Matters arising from the Minute

There were no matters arising from the Minutes.

Questions From The Public

Anne Woodcock and Gavin Brown, both of the Tweed Commission, were in attendance and Anne gave an update on preparations so far for the opening of the River Tweed Salmon Fishing Season.

She advised that the local schools, together with the Kelso Men's Shed, were now involved with the preparations.

Anne also reminded members that the event was coinciding with the inaugural River Tweed Fly-Tying Fair (1st and 2 February 2025) and there were fly-tyers coming from the Netherlands, Ireland and Aberdeen as well as the current world ty-flying champion from Germany.

The Provost thanked Anne and Gavin for their update and said this was a great opportunity to promote both the River Tweed and the town.

Mr Dominic Thomas asked if there was anything happening with regard to the proposed PlacePlans? The Provost replied that, at present, there was no available funding and he had received no further information. He was hoping to get this project started if funding became available.

Ryan Whellans advised the Committee that he was delighted with the outcome of his request for "Bug Hotels". The Provost said thanks was due to the local Scottish Borders Councillors and the people from the Community Paypack /Unpaid work team.

Kelso In Bloom

Councillor Shirley Redgrave commented on the state of the bedraggled signage on the Coldstream Road and asked if something could be done about it? The Provost advised that this sign would be taken down shortly.

SBCCN

The Provost advised that there was to be a meeting regarding the Review of Non-Financial Support to Community Councils. Kelso Community Council and Oxnam Community Councils were to provide the Lead and Depute for this. He had only just been informed of this development and would hopefully receive an update soon.

Provost Report

The Provost would be attending the opening of the River Tweed Salmon Fishing Season on 1st February 2025 together with other events involved with the Fly-Tying Fair on 1st and 2nd February.

Scottish Borders Council Report

1. Starbucks

SBC Tom Weatherston advised that he was still being told that a decision on the Starbucks application was "imminent".

2. St Mary's Church

There was no further update on St Mary's Church.

3. Union Street

SBC Tom Weatherston said, with regard to the scaffolding still being in place he would follow this matter up and report back.

4. Maxmill, Kelso

Councillor S Redgrave asked what the current position was regarding the properties at Maxmill? SBC Tom Weatherston advised that there were now only 4 properties inhabited and as soon as the last property was empty, the site would be advertised on the open market go.

- 1. The Provost advised that he had received a request from SBC Councillor John Greenwell proposing a VE Commemoration event at Floors Castle on 10 May 2025 (this will be the 80th Anniversary). The Provost advised he [Mr Greenwell] was currently waiting to hear from the Regiment of Scotland whether this would be allowed and suggested that there would likely be other events taking place in the town.
- 2. The Community Council was advised that, as this was their fourth year of Office, there would be Community Council Elections in October.
- Councillor S Redgrave asked whether there had been any interest shown in the position of Treasurer? She had previously advised the Council that she would be giving up the post at election time.
